III. Presentation of the 2024 Proposed Budget: Kip Lewis, Cathye Huckaby, Jim Banks.

- a. Kip Lewis, Hinton & Burdick CPA (contracted with NHVSSD) assisted Office Manager Cathye Huckaby in preparing the 2024 Proposed Budget for the NHVSSD. He took the lead on presenting the information to the Board. Highlighted points are as follows:
 - Budget vs Actuals FY 2023, January – December, dated 11-15-2023 (See Attachment) was reviewed in detail. The conclusion being that the district did a good job staying within the 2023 budget.
 - Balance Sheet as of 11-15-2023 (See Attached). A discussion occurred about moving the money from the Impact Fee Account to a higher interest yielding account. It was decided to table the discussion until the first of the year 2024.
 - Budget line items and categories have been updated to show a clearer picture in next year's budget. (See Attachment).
 - The 2024 Proposed Budget (See Attachment) was presented and thoroughly reviewed.

IV. Board Follow-up Questions.

- a. Having just been through the mid-year budget review process in August the Board was familiar with the numbers and what was being presented.
- b. Clarification was provided as to the logic behind listing more line items in the budget/QuickBooks which was to further identify specific areas and not as subcategory listings.
- c. It was noted that the increase in revenue, resulting from mill rate increase through the TNT process, will not be received until December of 2024.

V. Community Members Comments.

- a. Members of the community were given an opportunity to ask questions. No questions or comments were offered. The Board thanked those present for their attendance.

VI. Board Members/Fire Chief Reports:

b. Chief Report:

- We currently have 3 volunteers in the Fire Fighter I & II Academy expected to graduate in December 2023.
- Most of our volunteers, and one Board Member, will be attending 2024 Winter Fire School, held in Saint George, for which they can receive state certification.
- Zion Mutual Aid Agreement has expired, and they are working on a new agreement.
- We have one new volunteer, Brayden Fawcett.
- Working on closing the 2023 ISO Report including Pump Testing, Hose Testing, Hydrant Inspections.
- Continue to conduct Fire & Safety Inspections. Completed Hope Rising, Kolob RTC, one AB&B. Scheduled is Zion Visitor Center & Painted Desert.
- Overview of meeting with Washinton County Commissioners. Golden Cross has no contract agreement on “reasonable service minimums” with Washington County. Discussed the TNT and ISO process and outcomes, the need for county support, the thought of combining resources with other agencies and counties (Cedar City Specifically).
- There have been reports the township may be considering leaving the district. The chief addressed this concern to the town council. It appears that this is a small group of constituents and not sanctioned by the council. Per Washington County Legal Counsel, should they proceed, they would not be entitled to any equipment.
- The delay in the delivery of the new truck is due to the a delay getting the chassis.

VII. Public Comment:

- a. Fire Association: Sonia Steere, President provided an overview of the 2023 Apple Festival. The event went very well, final numbers are not yet available. The association is allocating funds towards the purchase of helmets. The following events are scheduled:

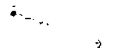

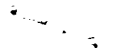

9 **General Description:**

10 This bill modifies provisions related to the Volunteer Emergency Medical Service
11 Personnel Insurance Program.

12 **Highlighted Provisions:**

13 This bill:

14 ▶ defines terms;

15 ▶ expands eligibility for the Volunteer Emergency Medical Service Personnel
16 Insurance Program (program);

17 ▶ allows the program to offer dental benefits, life insurance benefits, and disability
18 insurance benefits;

19 ▶ renames the program; and

20 ▶ makes technical changes.

21 **Money Appropriated in this Bill:**

22 None

23 **Other Special Clauses:**

24 This bill provides a special effective date.

31 *Be it enacted by the Legislature of the state of Utah:*

32 Section 1. Section 49-20-201 is amended to read:

33 **Part 2. Membership Eligibility**

34 **49-20-201. Program participation -- Eligibility -- Optional for certain groups.**

35 (1) (a) The state shall participate in the program on behalf of the state's employees.

36 (b) Other employers, including political subdivisions and educational institutions, are
37 eligible, but are not required, to participate in the program on behalf of their employees.

38 (2) (a) As provided in Subsection 26B-3-908(5), the Department of Health and Human
39 Services may participate in the program for the purpose of providing health and dental benefits
40 to children enrolled in the Utah Children's Health Insurance Program created in Title 26B,
41 Chapter 3, Part 9, Utah Children's Health Insurance Program.

42 (b) If the Department of Health and Human Services participates in the program under
43 the provisions of this Subsection (2), all insurance risk associated with the Utah Children's
44 Health Insurance Program shall be the responsibility of the Department of Health and Human
45 Services and not the program or the office.

46 (3) Volunteer emergency medical service personnel are eligible to participate in the
47 program in accordance with Section [~~26B-4-136~~] 53-2d-703.

48 (4) A covered individual shall be eligible for coverage after termination of employment
49 under rules adopted by the board.

50 (5) Only the following are eligible for Medicare supplement coverage under this
51 chapter upon becoming eligible for Medicare Part A and Part B coverage:

52 (a) retirees;

53 (b) members;

54 (c) participants;

55 (d) employees who have medical employee benefit plan coverage at the time of their
56 retirement; and

57 (e) current spouses of those who are eligible under Subsections (5)(a) through (d).

63 (a) "Basic life insurance benefit" means the standard group life insurance benefit
64 offered by PEHP that combines basic life, line-of-duty, accidental death and disability, and
65 dependent coverage into one benefit package.

66 (b) "Basic long-term disability benefit" means a \$1,000 monthly benefit arising from a
67 disability determined in accordance with Title 49, Chapter 21, Public Employee's Long-term
68 Disability Act and excluding any coverage offered on a pilot basis.

69 (c) "Dental plan" means the same as that term is defined in Section 31A-22-646.

70 (d) "Health benefit plan" means the same as that term is defined in Section 31A-1-301.

Nothing major this month, mostly wrapping up issues from 2023.

We spent some funds replacing the bay and most interior lights with LED fixtures. These draw much less current and have a longer lifespan than the old fluorescent type. I also have new floodlights for the rear of the station. They will be activated by motion sensors, as to minimize the impact on the neighbors.

We ended 2023 with XX calls for service. I have attached a recap for your review.

We purchased shelving for the storage room and cleaned it up considerably. We also bought some new hand tools to help with maintenance.

Malcolm and team removed a section of the parking lot asphalt and replaced it with sloped concrete to better drain standing water on the east side of the lot.

Malcolm also graded the unpaved portion of the rear lot and we covered it with crushed gravel to use as a training area.

We have secured a donated vehicle for extrication practice.

We have three new graduates from the Southwest-Tech Fire Academy. They are Firefighter I/II and HazMat First-Responder certified.

EVS installed reflective striping on the rear of the Not-An-Ambulance for NFPA compliance and better visibility. The team identified it also needs new tires before it can be placed into service. There are a few remaining items to complete also, such as radio installation and securing the items we are moving from the Chief's truck.

Once that is complete, the Chief's Truck will be emptied of equipment and used as a utility and possible future response vehicle for civilian EMR's.

The new Fire Engine is tentatively scheduled for construction mid-2024. Delivery is expected in Spring 2025.

The 2023 holiday & awards dinner and the Santa event were a huge success and well-attended. The Fire Association did a great job as usual and donated some great safety and clothing items to our First Responders.

We have an immediate need to replace the air-compressor at the Kolob Station. The current one is failing and needs to be a commercial unit capable of 24/7 operation at high pressures. The estimated cost is \$3500. I would like to purchase this by the end of this month.

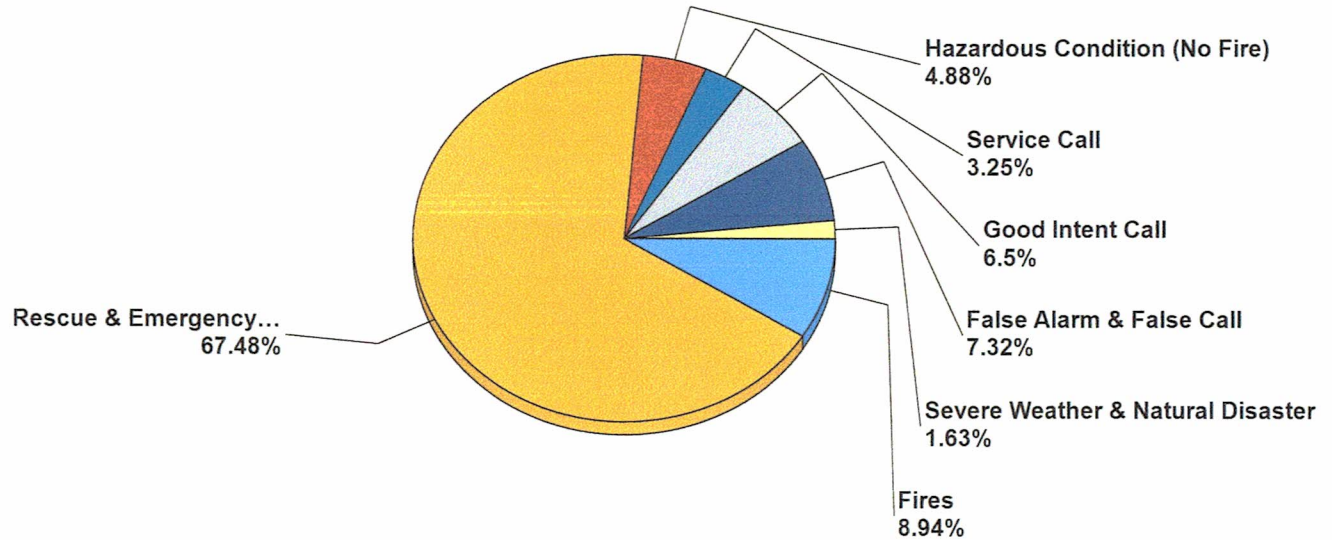
